**ORDER**

BY ORDER of this Court, the attached schedule constitutes the official schedule for the Chattahoochee Judicial Circuit for the year 2012, and takes priority over any matters not scheduled hereon, subject to the Uniform Superior Court Rules and applicable Georgia Statutes.

“(P.J.)” on the schedule indicates “Presiding Judge” for that week, which is responsible for hearing all Temporary Protective Orders, Instanters, Search Warrants, and other walk-in matters requiring immediate signature of a Superior Court Judge.

DM-A, DM-B, DM-C, and DM-D indicate the divisions to which domestic actions are assigned. The judge (or judge’s secretary) assigned to that division shall schedule all hearings related to an action in that division. The judge assigned to each division conducts all hearings including final disposition of each matter assigned to that division.

All civil cases are assigned to a particular judge for all hearings to final disposition. All six judges are assigned their own civil cases.
