Whereas, this statement is absolutely false and without any foundation, in fact the City Commission of Columbus, having co-operated with the City Manager Hinkle, in every possible way since January, now

Therefore, be it resolved, that the office of the City Manager of Columbus be, and it is hereby declared vacant.
