

## ELECTRICAL SERVICE REQUEST FORM

**General Instructions:**

- A. All electrical service charges must be paid prior to the opening of the exhibit.
- B. Initial rate quoted is based on a maximum three-day show. Example: An advance order for 0-500 watts for 1-3 days would cost \$24.00. Each show day beyond three days will be prorated daily as an increment of the initial rate.
- C. If unable to determine electrical requirements, contact Trade Center electrician for assistance.

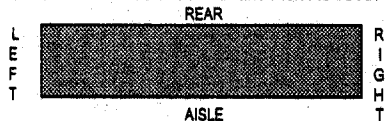
**STANDARD ELECTRICAL SERVICE AVAILABLE ONLY:**

120 Volt, A.C., sgl. phase, 60 cycle  
 208 Volt, A.C., sgl. phase, 60 cycle  
 208 Volt, A.C., 3 phase, 60 cycle (limited locations - contact Trade Center electrician for details and assistance.)

**CONDITIONS AND REGULATIONS:**

1. Wall, column and permanent building utility outlets are not a part of booth space and are not to be used by exhibitors unless specified otherwise.
2. All equipment, regardless of power source, must comply with all federal, state and local safety codes.
3. Use of open clip sockets, latex or lamp cord wire, duplex or triplex attachment plugs in exhibits is prohibited.
4. Under no circumstances shall anyone other than Trade Center staff make electrical connections.
5. Special equipment requiring the electrician or technicians for assembly, servicing, preparatory work and operation may be executed without Trade Center staff; however, all service connections and overload protection to such equipment must be made by Trade Center staff.
6. All equipment must be properly tagged and wired with complete information as to type of current, voltage, phase, cycle, etc.
7. All material and equipment furnished by the Columbus, Georgia Convention and Trade Center for this service order shall remain the Trade Center's property and shall be removed by our staff at the show close. Exhibitors will be billed for all missing materials.
8. Electrical power for lights and displays will be turned on one hour prior to the show opening time and off at show closing time daily unless you have requested and paid for 24-hour service.
9. Unless otherwise directed, Trade Center electricians are authorized to cut floor covering to permit installation of service.
10. All exhibitor's cords must be of the 3-wire grounded type. All exposed noncurrent carrying metal parts of fixed equipment, which are liable to be energized, shall be grounded.
11. Rates quoted for all connections cover only the bringing of service to the booth in the most convenient manner and does not include connecting equipment or special wiring.
12. Advance orders with payment must be received a minimum of three (3) days prior to exhibitor arrival for move-in.

**II. ELECTRICAL SERVICE CONNECTIONS:**

SINGLE PHASE - Watts = Amps x Volts (Based on actual load - one triplex receptacle furnished.)

THREE PHASE - Watts = Volts x Amps x Power Factor x 1.73 + 1000. Example: A three-phase, 208 volt (AC) motor draws a current of 26 amps and has a power factor rating of 80%. Determine the watts:  
 $W = E \times I \times PF \times 1.73 = 208 \times 26 \times .80 \times 1.73 = 7,485 \text{ Watts}$
