Board Meeting September 20, 2018

The minutes from the last board meeting will be emailed to all board members.

It was discovered that the Dislocated Worker Program had \$200,000 that they needed to spend by June 30th. The Executive Committee approved a new OJT Service, to train the workers of NCR and First Data employees which will allow them to go to other companies. We are looking at doing a Job Fair in the near future.

Financial Report because of the change the WIOA Program is going through (going under the Technical College System of Georgia, Office of Workforce Development) we received our funds late. THE WIOA Program lost about \$50,000.00.

Performance all but the out of school youth met the performance goals. In some cases we exceeded the goals. We are trying to get with the State to see if we can get a waiver from the 75% out of school youth and go to 50% (50% for out-of-school youth and 50% in-school youth).

We are currently trying to start a service with Andrew College. The service for the military dislocated worker program is being looked at, there have been some concerns that the only participants entering the program are officers.

Our Plan updates are due by the 9th of November. Chester Randolph announced the next board meeting will be conducted by the Board committee members. All board members will receive a copy of the various committees and their duties. Chester Randolph stated he would like to have a training for the board members in the future.
